Explanatory note

This note is not part of the instrument, but is intended to indicate its general effect.

This instrument, which comes into force on 1 April 2019, amends a Ministerial direction and a number of Ministerial welfare programmes under the Social Security Act 2018.

Clause 4 and Schedule 1:

 adjusts certain rates, standard costs, and limits in relation to the Direction in relation to Special Benefit, Family Start and Early Start (Childcare Assistance) Programme, New Employment Transition Grant Programme, and Seasonal Work Assistance Programme to reflect a 1.69% increase in the New Zealand Consumers Price Index from the December 2017 quarter to the December 2018 quarter (calculated using the CPI All Groups excluding cigarettes and other tobacco products)

Clause 4 and Schedule 2 amends:

- the Home Help Programme, to adjust the hourly rate to reflect a 7.27% increase in the adult minimum wage:
- the Special Transfer Allowance Programme 2000 to adjust average regional rents to reflect movements in rentals:
