#### **Instrument**

#### 1 Title

This instrument is the Instrument amending Ministerial Directions and Welfare Programmes (No 2) 2018.

#### 2 Commencement

This instrument comes into force on 26 November 2018.

#### 3 Principal directions and programmes

This instrument amends—

Explanatory note

This note is not part of the instrument, but is intended to indicate its general effect.

This instrument, which is made under sections 7 and 101 of the Social Security Act 2018 (the **Act**) and regulations 90 and 211 of the Social Security Regulations 2018 and comes into force on 26 November 2018, amends the Ministerial directions and welfare programmes under the Social Security Act 1964 (and saved by Schedule 1 of the Act) that are listed in the Schedule of this instrument in the manner set out in that Schedule. The amendments update references to provisions of the Social Security Act 1964 to equivalent provisions of the Act or the Social Security Regulations 2018 and for changes of language in the Act. It also revokes a spent direction and welfare programme.
