On 12 September 2016 you emailed the Ministry requesting, under the Official Information Act 1982, information regarding the tender for emergency housing funding. I will address each of your questions in turn.

The Ministry of Social Development sought proposals from providers who were delivering or intending to deliver Emergency Housing Accommodation. The aim of this service is to provide short-term accommodation for individuals and households who have an urgent need for accommodation. Funding provided through this Request for Proposal (RFP) is for the operational costs associated with the delivery of Emergency Housing accommodation.

The RFP included a fast-track option (which closed on 22 June 2016) for Government-funded providers of existing emergency housing places or existing emergency housing providers that hold Level 2 Approval.

1. A list of the applicants to this fund

I can advise that 39 providers responded to the Emergency Housing Accommodation RFP which closed on 13 July 2016. Of those, the Ministry has committed to contracting with 30 organisations that are providing 758 places. Please note a place can contain more than one bedroom. As advised by Ministerial and Executive Services on 7 October 2016, the Ministry is unable to release details relating to the other nine respondents due to commercial sensitivity. Eight providers require further discussion and one provider was declined due to not meeting the relevant criteria. As such, this information is withheld under section 9(2)(b)(ii) of the Act as, if released, would be likely to prejudice the commercial position of the person who supplied or who is the subject of the information. The greater public interest is in ensuring that the commercial position can be maintained.

2. How much funding each was granted?

Please refer to the enclosed table which provides the total amount of funding per annum that each fund was granted, broken down by region.

3. Any criteria around what applicants could spend funding they won on?

As per the Emergency Housing RFP, the funding is for accommodation for emergency housing places. Funding delivered through the RFP is for the operational costs associated with the delivery of Emergency Housing accommodation.

The shorter-term accommodation will provide a stable place for the individual or family to stay while their needs can be understood and addressed and a longer-term solution can be found. Any accompanying support services (not subject to funding under this RFP) should assist individuals or families to find a longer-term accommodation solution within an average stay of 12 weeks.

4. A total amount of contestable funds available

As part of Budget 2016, the Government committed \$41.1 million over four years towards a new emergency housing funding approach to bolster support for vulnerable New Zealanders with nowhere to live. 5. A total amount of funds allocated

As at 16 September 2016, the total amount of funds allocated was \$4,120,180.

- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

The Ministry will do this by publishing this letter on the Ministry of Social Development's website.
