On 20 July 2016 you emailed the Ministry requesting, under the Official Information Act 1982, the following information:

- Any reports, briefings, aide memoirs, research, and advice given to the minister that are about, or include mention of, the Ministry of Social Development contract providers whose contracts were not continued as of the 30th June 2016; and
- The names, and copies of funding applications, of the contract providers whose contracts have been discontinued as of the 30th of June 2016.

On 5 September 2016, you were contacted by a Ministerial and Executive Services advisor that advised that the copies of the reports, briefings and aide memoires that were provided to the Ministers will be provided by Minister Tolley and Minister Goodhew accordingly.

I have enclosed five tables that provide you with the names, services, region and the contracted value of each of providers who contracts will expire on 30 June 2016. This information has been provided previously by Hon Anne Tolley, Minister for Social Development, in her response to written parliamentary question 9000 (2016) and available at: www.parliament.nz/en/pb/order-paper-questions/written-questions/document/QWA 09000 2016/9000-2016-poto-williams-to-the-minister-for-social-development

I have considered whether the Ministry would be able to respond to your request given extra time, or the ability to charge for the information requested. I have concluded that, in either case, the Ministry's ability to undertake its work would still be prejudiced.
