On 25 January and 14 February 2017, you emailed the Ministry requesting, under the Official Information Act 1982, information relating to all emergency housing providers in the Waikato region and a list of all contracted emergency housing providers.

On 2 February 2017 your request was refined to the following: the dollar value amount of Emergency Housing Special Needs Grants (SNG) granted for a list of 23 motels in the Waikato region.

Further to our conversations, the data you sought was not standard reporting for the Ministry and therefore required further analysis and collation. I would like to extend my apologies for the delay in responding to your request and hope that this information provided is of help to you.

On 1 July 2016, the Government introduced a non-recoverable emergency housing Special Needs Grant (SNG) to help people who need emergency housing. This Emergency Housing SNG is payable for up to seven days to help individuals and families with emergency housing needs, while the Ministry works with the individual to investigate alternative housing options. In most cases this grant does not need to be repaid.

In response to your request for data relating to a list of specific motels in the Waikato region, the Ministry can provide the two enclosed tables (table one and table two) which show the number and dollar value amount of Emergency Housing SNGs approved for accommodation in Hamilton, by quarter between 1 July 2016 and 31 March 2017. Please note that six of the motels you specified (Albert Court Motor lodge, Auto lodge motel, Astra Motor Lodge, Beetham Park Motel, Motel six, Fountain City Motor Inn and the Eagles Nest Backpackers) are not shown on these tables, meaning they either have not received payments for Emergency Housing SNGs or have not received any credit card or direct credit payments for Emergency Housing SNGs.

In 2016, the Ministry released a Request for Proposals (RFP) for Emergency Housing, which sought to deliver up to 800 places across New Zealand at any one time. That RFP was intended to provide immediate financial support to existing emergency housing providers and closed in July 2016. Subsequently, in October 2016 the

Ministry issued an Invitation to Partner (ITP) for emergency housing accommodation providers to deliver an additional 1,400 emergency housing places and accompanying services throughout New Zealand at any one time. Previous to those processes, in 2015, the Ministry contracted providers to deliver short-term housing and associated support services in Auckland and Christchurch to support the needs of vulnerable individuals and families.

Contracted emergency housing places are available to clients with an urgent housing need for a stay of up to three months, with the possibility of a further three months support dependent on circumstances, while the Ministry works alongside contracted providers to help clients move towards sustainable long term housing.

Table three below, notes the emergency housing providers with whom the Ministry had an active contract as at 31st March 2017.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public shortly. The Ministry will do this by publishing this letter on the Ministry of Social Development's website. Your personal details will be deleted and the Ministry will not publish any information that would identify you as the person who requested the information.
