On 19 April 2018, you emailed the Ministry requesting, under the Official Information Act 1982, the following information:

Could I please request the following information for the 2015/2016 and 2016/2017 financial year ending in June?

- The number of children assisted by a Child Disability Allowance (and a breakdown of whether the caregivers were on main benefits, superannuation or neither).
- The number of children for whom a Child Disability Allowance was granted (and a breakdown of whether the caregivers were on main benefits, superannuation or neither).
- The number of people for whom a Disability Allowance was granted (and a breakdown of whether the person, or caregivers, were on main benefits, superannuation or neither).

Enclosed are three tables that respond to your request and the Ministry's previous response to you, dated 15 February 2016, for your reference.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public shortly. The Ministry will do this by publishing this letter on the Ministry of Social Development's website. Your personal details will be deleted and the Ministry will not publish any information that would identify you as the person who requested the information.

On 2 December 2015 you emailed the Ministry requesting, under the Official Information Act 1982, the following information:

- The number of children assisted by a Child Disability Allowance for the 2014/2015 years (and a breakdown of whether the caregivers were on main benefits, superannuation or neither).
- The number of children for whom a Child Disability Allowance was granted for the 2014/2015 years (and a breakdown of whether the caregivers were on main benefits, superannuation or neither).
- The number of people for whom a Disability Allowance was granted for the 2014/2015 years (and a breakdown of whether the person, or caregiver, was on main benefits, superannuation or neither).
- The ethnicity breakdown, the continuous duration and age group of the Supported Living Payment for carers and the former Domestic Purpose Benefit care of sick and infirm from 2000 to 2015 (just the data from June of each year would be great).
- If possible, the age of the person being supported by the caregiver under a Supported Living Payment for carers/former Domestic Purpose Benefit care of sick and infirm from 2000 to 2015 (if that data is collected).
- Reasons for leaving the Supported Living Payment for carers/former Domestic Purpose Benefit – care of sick and infirm from 2000 to 2015.
- The benefit transferred from for Supported Living Payment for carers/former Domestic Purpose Benefit care of sick and infirm from 2000 to 2015.

Child Disability Allowance is a non-taxable allowance available to the primary caregiver of a child who is diagnosed with a physical, sensory, psychiatric or intellectual disability. Child Disability Allowance is paid at a standard rate and is not income tested. It is usually paid to the primary carer in recognition of the extra care they provide to a child with a severe medical condition compared to that required for a child of a similar age who is not impaired. It is not related to any particular financial costs incurred in relation to the child's disability.

People may also be eligible to receive a Disability Allowance to meet any additional costs the dependent child may have due to their disability. Disability Allowance is an income tested, non-taxable form of financial assistance available to people and their dependent children who have on-going additional costs resulting from a disability.

A number of eligibility factors are considered when assessing a person's eligibility for these allowances and further details about criteria and payment are available on the Work and Income website at: <a href="https://www.workandincome.govt.nz">www.workandincome.govt.nz</a>.

As you will be aware, from 15 July 2013, New Zealand's welfare system changed. The Domestic Purposes Benefit – Caring for Sick and Infirm benefit transitioned to the Supported Living Payment – Carer from this date.

Supported Living Payment – Carer is paid to an applicant who is caring full-time at home for a person (other than their spouse or partner) who, if they were not being cared for at home, would otherwise need hospital or similar care. Supported Living Payment – Carer cannot be paid to more than one carer for the same supported person.

You will note that the number of Disability Allowance grants has decreased between the 2013/14 and 2014/15 financial years. This is largely due to an overall decrease in the number of people receiving main benefits, notably Jobseeker Support and Sole parent Support. Following the Global Financial Crisis in 2008, there was an increase in the number of people coming onto benefit, which meant that the numbers of Disability Allowance also increased between the 2008/09 and the 2009/10 financial years. As the economy recovered, the number of beneficiaries has decreased, as has the number of people receiving Disability Allowance.

The Ministry is unable to breakdown the number of Domestic Purposes Benefit – Caring for Sick and Infirm by continuous duration, prior to 2012/13 as this data is not held in a reportable format and as such, this part of your request is refused under section 18(e) of the Act as it does not exist.

The Ministry is unable to report the age of the person being supported by the caregiver who is in receipt of Supported Living Payment – Carer, or Domestic Purposes Benefit – Care of Sick and Infirm. As such, this part of your request is refused under section 18(e) of the Act as it does not exist in the manner you have requested.

The Ministry is unable to provide the benefit people in receipt of Supported Living Payment – Carer or Domestic Purposes Benefit – Care of Sick and Inform transferred from. This information does not exist in a form that can be reported on and provided in the manner you have asked for. As such, your request is refused under section 18(e) of the Act.
