On 13 April 2018, you emailed the Ministry requesting, under the Official Information Act 1982, the following information:

• I understand some beneficiaries are being housed at campgrounds — caravans, cabins — by the Ministry, in an effort to provide them with accommodation. How many beneficiaries are being housed like this for each of the last 3 years — including the type of accommodation? I would also like to know how much was spent and whether the beneficiary is expected to pay back the sum.

Thank you for your confirmation on 4 May 2018 that the provision of data on Emergency Housing Special Needs Grants from the September 2016 quarter to the December 2017 quarter, broken down by whether the grant was recoverable and the type of accommodation funded, would meet the intent of your request.

It is important to note that while the Ministry encourages clients to explore alternative accommodation and provides options, advice and financial assistance to support their housing needs, the final decision over where they live remains with the client.

On 1 July 2016, the Ministry introduced a non-recoverable Emergency Housing Special Needs Grant. This grant has been made available to people who cannot remain in their usual place of residence, if any, and do not have access to other accommodation which is adequate for their or their family's needs. Assistance is generally granted for up to seven nights, but can be extended depending on an individual's circumstances. In most cases the grant does not need to be repaid. An individual does not need to be in receipt of a Benefit to qualify for an Emergency Housing Special Needs Grant.

Prior to the 2016 December quarter, emergency housing related hardship grants were coded in the Ministry's IT system as 'other emergency grants', which included hardship grants for various other emergency reasons. As such, the Ministry cannot disaggregate emergency housing hardship payments from other types of assistance granted under the 'other emergency grants' category and any information regarding emergency housing grant payments prior to the December quarter is recorded in notes on individual case files.

As such, please find attached a table providing Emergency Housing Special Needs Grants from the December 2016 quarter to the December 2017 quarter, broken down by the type of accommodation funded by and whether the grant was recoverable. I have also included information from the September 2016 quarter, however, it is not able to be broken down by accommodation type. It is also important to note that an Emergency Housing Special Needs Grant is granted for up to seven days at a time and as such clients are eligible for more than one payment.

You will note that some clients received Emergency Housing Special Needs Grants to stay in holiday parks, campgrounds and hostels. Generally, all three types of accommodation include private bedrooms, or in the case of campgrounds, cabins, with shared cooking facilities and communal spaces. While it is not the Ministry's preference to utilise these types of accommodation, and our staff do not refer clients to them, we have met those costs on occasion including, where the client has identified that option themselves, or as a last resort where no alternative accommodation options exist. You will note that use of holiday park, campground and hostel accommodation has generally declined over time as the Ministry has contracted more transitional housing places, which provide not only stable accommodation but wrap-around support to help people get their lives back on track.

- Data in this quarter includes security deposits paid to providers.
- Data was cleaned to exclude grants that were not granted to Emergency Accommodation providers and as such will not total to previously published data. This was a manual exercise and as such cannot be replicated or broken down further.
- The data for the September 2016 quarter should not be compared to other quarters, as a different methodology is used to estimate Emergency Housing SNGs in this quarter.
