On 19 March 2018, you emailed the Ministry requesting, under the Official Information Act 1982, the following information:

• Is it possible to find out how many school leavers left school and went on a benefit in the last say 3 years. Looking at the Manawatu/Whanganui Region?

The Ministry records various reasons for clients entering into a benefit. Please find enclosed a table that shows the number of main benefit grants for clients 16 to 18 years of age in the Whanganui/Manawatu area for reason "school/tertiary college finished" and "exams finished" by calendar year between 2015 and 2017. Please note, any school leavers that were recorded as receiving a benefit under a different reason will not be represented in this table.

Please note this data does not cover clients on a Youth Payment or Young Parent Payment as a client must be in, or available for, full time education, training or workbased learning leading towards an NCEA level 2 qualification, or an equivalent or higher qualification in order to qualify for these two benefits.

Please note the data for Jobseeker Support (JS) only includes 18 year olds, as clients are only eligible for JS if they are aged 18 years or over.
