Thank you for your email of 26 February 2019 requesting, under the Official Information Act 1982, the following information:

How much money was spent on new furniture in 2017 and in 2018? Please breakdown the total cost by year. Please also include what the most expensive item of furniture was in 2017 and in 2018 and how much they cost each.

New Zealand's public service is responsible for ensuring that funds provided to it by the Crown are spent prudently. In its capacity as a provider of a wide range of support services to over one million New Zealanders through more than 150 offices, the Ministry of Social Development (the Ministry) has guidelines in place that ensure sensible stewardship of public monies. The Ministry's financial policies are governed by the overarching consideration of probity.

Over the last five years the Ministry has experienced some significant organisational changes that impact on its reporting on its spend on furniture and office supplies. Most notably, on 1 April 2017 Oranga Tamariki was established. However, the Ministry has continued to provide the office environments to Oranga Tamariki under an occupancy agreement. As such, the spending reported in 2017 and 2018 includes purchases made for offices occupied by Oranga Tamariki.

The Ministry has a rolling approach to the refurbishment of offices, which takes into consideration other impacts such as the end of leases on buildings.

In order to respond to your request, the data has been pulled from the Ministry's financial system using the date the invoice is paid. This date may differ from the date the purchased items were delivered. In compiling this data, the Ministry has reviewed transactions and grouped them in accordance with the invoice coding. These have been identified as:

- New Site Projects a new office building being occupied by the Ministry, generally this is relocation from an existing site, which is defined as an area of land on which two or more property leases are held (note that this excludes Oranga Tamariki Family Homes and Residences)
- Refurbishments an upgrade to an existing site completed as a capital project, which includes projects where similar work was completed across a number of sites
- Operating costs purchases of individual items to meet specific needs or to replace broken items.

Please find enclosed a table that shows a breakdown of the Ministry's expenditure on furniture for the financial years for the period 2016/17 and 2017/18.

You will see that there was a significant higher spend in 2016/17. This was largely as a result of the fit-out of the Ministry's new National Office after it moved from its site on Bowen Street. If you are interested in this, further information is available on the Ministry's website at:

You have also specifically asked about the most expensive item of furniture purchased each year. I can advise that in both 2017 and 2018 the most expensive single item purchased at a unit cost of \$5,506 (excluding GST) was a large, tall meeting room table with integrated cabling, which provides for a collaborative workspace that can utilise technology. These tables are used to better support teamwork within collaboration spaces.

I hope that you find this information helpful.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public shortly. The Ministry will do this by publishing this letter on the Ministry of Social Development's website. Your personal details will be deleted and the Ministry will not publish any information that would identify you as the person who requested the information.
