On 1 August 2019, part of your request for information from the Tertiary Education Commission (TEC) was transferred to the Ministry of Social Development (the Ministry), under the Official Information Act 1982. The following questions were transferred:

- For the period 2000 to 2018, [please provide] the following information for the Bachelor of Aviation programme at Massey University: The average student loan amount per student, and the gender and age breakdowns of these students.
- For the period 2000 to 2018, for all institutions providing flight training under the Tertiary Education Commission (TEC): The average student loan size, and gender and age breakdowns of these students.

The Ministry of Social Development, through StudyLink is responsible for testing eligibility to, and making payments for student loans. As such, the Ministry holds information on the average student loan amounts per student, and that part of your request was thus transferred to the Ministry.

The Tertiary Education Commission/Te Amorangi Mātauranga Matua leads the Government's relationship with the tertiary education sector in New Zealand and provides career services from education to employment.

As TEC holds information regarding individual education providers and course or programme codes, they have provided table seven (enclosed) for your reference, and to assist in the creation of tables one through six.

Please find enclosed seven tables that provide the requested information.

In order to protect client privacy, some values in table two and three are suppressed and are represented by 'S'. The Ministry is unable to provide you with the exact number as releasing this information is likely to risk identifying the individuals concerned. As such, this information is withheld under section 9(2)(a) of the Act. The need to protect the privacy of these individuals outweighs any public interest in the information. Unfortunately this means that a comprehensive breakdown of the age and gender of Massey University Bachelor of Aviation students cannot be provided.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public shortly. The Ministry will do this by publishing this letter and attachments on the Ministry of Social Development's website. Your personal details will be deleted and the Ministry will not publish any information that would identify you as the person who requested the information.

## Notes for Tables One through Seven:

- Loan totals include course fees, living costs, and course related costs payments.
- · Year is based on study start date.
- Living costs and course related costs cannot be directly attributed to a single qualification. In some cases, there may be additional qualifications associated with these.
- Course fees cannot always be attributed to one qualification, as a student may be studying more than one qualification at any given time.
- Course fees are only those paid to education providers, no allowance has been made for course fees refunded by the education provider.
- In certain circumstances low numbers may potentially lead to individuals being
  identified. Due to these privacy concerns, numbers for some categories of clients
  have been suppressed or aggregated. Secondary suppression rules have also been
  applied when required. Suppressed numbers have been replaced by an 'S'.
