On 4 June 2020, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

Statistics on the number of people in social housing in NZ and their demographics.

Public (social) houses are properties rented out by Kāinga Ora (previously Housing New Zealand) and other Community Housing Providers (CHPs). The properties can be tenanted by people who are assessed as eligible by the Ministry.

The Ministry assesses the eligibility of individuals for public housing and manage the Housing Register and Emergency Housing. The Ministry of Housing and Urban Development (HUD) manages public housing and monitor community housing providers.

Public housing applicants must have a serious housing need as well as meet a number of requirements to be eligible for public housing, such as, but not limited to:

- Being lawfully resident and ordinarily living in New Zealand with a period of prior residence in New Zealand
- Aged 16 years or older
- Have a low income and little or no cash assets

It is important to note that other members of a household do not need to meet the same criteria as long as they can show that they are either a dependent child or have a specific and established on-going need to be a member of the household. For example, this refers to a couple where one partner does not meet the residency criteria, or an elderly parent or grandparents or a carer or support person.

Notes:

- Please note the ethnicity classification that is used to construct this table does not
 necessarily align with the current Statistics New Zealand classification of ethnicity.
 Ethnicity details recorded by the Ministry have been gathered under a variety of
 classification methods as clients come into contact with the Ministry. The ethnicity data
 may be self-identified based on an individual's preference or self-construct. While the
 Ministry collects multiple ethnicities from clients, we only report a unique form of
 'identified' ethnicity for core benefit data (one ethnic group per person with Māori coming
 first, Pacific groups second followed by other groups ending with NZ European).
- The household type is derived from the number of adults and children included in the tenancy.

In certain circumstances, low numbers may potentially lead to individuals being identified. In order to protect client privacy, some numbers have been suppressed. Suppressed numbers have been replaced by an 'S'. This information is withheld under section 9(2)(a) of the Act. The need to protect the privacy of these individuals outweighs and public interest in the information.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government
- to increase the ability of the public to participate in the making and administration of our laws and policies
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public. The Ministry will do this by publishing this letter on the Ministry of Social Development's website. Your personal details will be deleted and the Ministry will not publish any information that would identify you as the person who requested the information.
