On 17 May 2022, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

*Could you provide the method used to calculate the Disability Allowance threshold between the years 2008 - 2022?*

The income limits and maximum rate for Disability Allowance (DA) are adjusted by the Consumer Price Index (CPI) each year on 1 April. Each year (from 2008–2022) these rates and thresholds have been increased by CPI.

CPI is a measure of inflation for New Zealand households as it shows changes in the price of a fixed range of goods and services over time.

Prior to 2010, adjustments to rates and thresholds of social assistance which were indexed to the CPI were made based on the CPI (all groups).

In 2010, to prevent increases in tobacco excise tax resulting in the increase of rates and thresholds of social assistance, Cabinet agreed to use the CPI (excluding tobacco and other cigarette products) rather than CPI (all groups). These Cabinet decisions have now expired, and adjustments made using the CPI reverted to using the CPI (all groups) in 2022.

<b>Years</b>	<b>CPI used</b>
2008–2010	CPI (all groups)
2011–2021	CPI (excluding tobacco and other cigarette products)
2022	CPI (all groups)

The Annual General Adjustment (AGA) uses the percentage upwards movement for this definition of CPI, when comparing the CPI for the quarter ended 31 December (of the year prior to the AGA) against the same quarter of the preceding year.

DA income limits may be adjusted further to ensure that existing New Zealand Superannuation clients do not lose their entitlement because of wage-related adjustment.

In September 2010, the income abatement threshold for people receiving New Zealand Superannuation and Veteran's Pension with a non-qualified partner included increased from \$80 to \$100 per week. The DA income limit was increased by \$14

(for couples only) so that couples receiving income-tested New Zealand Superannuation or Veteran's Pension did not lose entitlement to DA as a result of the increased abatement threshold. In September 2017, the income thresholds for both singles (18+ years) and couples were adjusted to correct a minor error made in the April 2017 update.
