On 28 December 2021, you emailed the Ministry of Justice requesting, under the Official Information Act 1982 (the Act), the following information:

- how much funds were disbursed to the Community Builders Trust of Otara and how many leases were given to them too.
- I would like to have DATES AS WELL.

On 10 January 2022, your request was transferred to the Ministry of Social Development (the Ministry) under section 14 of the Official Information Act, as the subject matter is more closely related to the functions of the Ministry.

On 14 February 2022, the Ministry contacted you and advised that more time was required to make a decision on your request. The reason for this extension was that consultations necessary to make a decision on the request are as such that a proper response to the request cannot be made within the original time frame. The Ministry advised you that a decision would be with you on or before 29 March 2022.

On 29 March 2022, the Ministry advised you of its decision to grant your request, and that the Ministry intended to send the information to you by 29 April 2022.

I acknowledge that this date has passed, and I sincerely apologise for any inconvenience this has caused.

In regard to your request for information regarding leases given to the Community Builders Trust of Otara, the Ministry can confirm that the Ministry does not grant leases. Therefore, this part of your request is refused under section 18(e) of the Act as this information does not exist.
