- *A breakdown of the number and value (\$) of Special Needs Grants (SNGs) issued by the Wairarapa Community Link for the quarter ending 31 March 2022.*
- *Can this data please be provided per SNG category as per previous requests?*
- *Please supply data for all 'Need Reasons' when not suppressed (S). If suppressed, please include in 'Other' with note to say which categories are covered.*

Please find attached **Appendix One** containing **Table One**, which shows the number and amount granted for Special Needs Grants from the Wairarapa Service Centre for the period 1 January 2022 to 31 March 2022, broken down by need reason.

You will note some of your requested need reasons do not appear in the table. This is because the Ministry did not receive any applications under that need reason category during the quarter.

- To protect confidentiality the Ministry of Social Development uses processes to make it difficult to identify an individual person or entity from published data.
- These data tables have had random rounding to base three applied to all cell counts in the table.

- The impact of applying random rounding is that columns and rows may not add exactly to the given column or row totals.
- The published counts will never differ by more than two counts.
- A value of one or two may be rounded to zero or three.
