On 3 November 2022 you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

- The amount of monies received by Ritz Enterprises Limited trading as Takapuna Motor Lodge for Emergency Housing Special Needs Grants for the period 1 August 2022 to 31 October 2022. Could this be in separate months if possible rather than in one figure?
- The amount of monies received by Ark Hotels Limited for the DuPont Executive Motels and DuPont Motel in Lower Hutt for Emergency Housing Special Needs Grants for the period 1 August 2022 until 31 October 2022. Could this please be in separate months if possible rather than one figure?
- Also is it possible to know if these monies received for these Emergency Housing Special Needs Grants are subject to Goods and Services Tax (GST). For example, do the companies Ritz Enterprises and Ark Hotels pay the 15% GST in their GST returns to Inland Revenue Department. Or is this GST exclusive?
- The monies received by JGG Motels Limited trading as Orewa Motor Lodge for the Emergency Housing Special Needs Grants for the period of 1 April 2018 to 31 October 2022. Could this figure be in quarterly amounts not one total figure?
- The monies received by Ellerslie Palms Motel at 384 Ellerslie-Panmure Highway Auckland for Emergency Housing Special Needs Grants for the period of 1 April 2019 to 31 October 2022.
- I ask for this to be in quarterly increments not one total figure please.

Demand for housing across New Zealand continues to grow and more people are experiencing a severe and immediate need. This demand is generated by a shortage of affordable housing driving up house prices and rents. People

on low incomes are most affected by rising housing costs and many seek financial help through the Ministry.

The Emergency Housing Special Needs Grant (EH SNG) is available to people who cannot remain in their usual place of residence, if any, and do not have access to other accommodation which is adequate for them or their family's needs. The Ministry pays EH SNGs directly to the accommodation supplier and assistance is generally granted for up to seven nights but can be extended dependant on individual circumstances.

After these seven nights Work and Income arrange another appointment with the client to discuss their housing situation and if another grant is required. The Ministry works hard to support people in emergency housing to secure a long-term housing solution, either through public housing and private rental accommodation. Other options including transitional housing can also be explored as an option depending on availability and the individual's circumstances.

The Ministry recognises that motels are not a long-term solution or the solution that we want to deliver for people who are potentially in a vulnerable situation. They provide a short-term solution while more sustainable options are progressed. You further request:

• Also is it possible to know if these monies received for these Emergency Housing Special Needs Grants are subject to Goods and Services Tax (GST). For example, do the companies Ritz Enterprises and Ark Hotels pay the 15% GST in their GST returns to Inland Revenue Department. Or is this GST exclusive?

EH SNGs are subject to GST as they are payments for goods and services. You can find information about GST at Inland Revenue's website here: www.ird.govt.nz/gst. When suppliers provide quotes to the Ministry to support their applications for EH SNGs, their quotes include GST. However, the Ministry has no involvement in suppliers paying GST to Inland Revenue.

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.
