On 7 September 2022, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

- 1. Could we please ask MSD for a list of motels, hotels, hostels, holiday parks, campgrounds and shelters contracted to provide emergency and transitional housing in Southland. (I have tried to find a list online, but to no avail)
- 2. Could you also please tell us how many of these providers began their contracts with MSD in the past year (Ie. How many providers are there this year vs the year before).

Demand for housing across New Zealand is growing and more people are experiencing a severe and immediate need. This demand is generated by a shortage of affordable housing driving up house prices and rents. People on low incomes are most affected by rising housing costs and many seek financial help through the Ministry.

The Emergency Housing Special Needs Grant (EH SNG) is available to people who cannot remain in their usual place of residence, if any, and do not have access to other accommodation which is adequate for them or their family's needs. The Ministry pays EH SNGs directly to the accommodation supplier and assistance is generally granted for up to seven nights but can be extended dependant on individual circumstances.

After these seven nights Work and Income arrange another appointment with the client to discuss their housing situation and if another grant is required. The Ministry works hard to support people in emergency housing to secure a long-term housing solution, either through public housing or private rental accommodation. Other options including transitional housing can also be explored as an option depending on availability and the individual's circumstances.

The Ministry recognises that emergency housing is not a long-term solution or the solution that we want to deliver for people who are potentially in a vulnerable situation. They provide a short-term solution while more sustainable options are progressed. More information about EH SNGs is available at the following link:

In regard to question one, please find enclosed **Table One**, showing accommodation providers who received at least one Emergency Housing Special Needs Grant from 1 July 2020 to 30 June 2022, by financial year, broken down by Southern Territorial Local Authority.

It is important to note that the Public Housing factsheet does not give the names of Transitional Housing providers.

In regard to question two, I can advise you that the Ministry does not contract motels to provide emergency housing in New Zealand. The Ministry's current model of providing emergency accommodation that the Ministry is tasked with utilises Special Needs Grants (hardship payments) to pay for commercial accommodation options for people who are in urgent need of somewhere to stay.

EH SNG's are intended as a one-off grant and are not able to be paid in advance of the need, or beyond what an individual is entitled to at the time of application. Given the high level of need many clients experience, subsequent grants are applied for in succession, and these are paid for up to 21 days at a time. Notes for Table One:

- Emergency Housing assistance payments are granted as Special Needs Grants.
- For each financial year ending 30 June the listing includes suppliers who received at least one Emergency Housing Special Needs Grants in that period.
- Accommodation types are inclusive of Motel/Hotel, Hostel, Holiday Park/Camp ground and Shelter.
- Southland includes the Gore District, Invercargill City and Southland District Territorial Local Authorities.
- Territorial Local Authority (TLA) is estimated based on the client's address at the time
 of the grant. It may not be the same as the address of the emergency housing provider.
- A supplier may be included under multiple TLAs depending on the addresses of the clients they have housed.
- One registered supplier may provide accommodation across multiple premises. These
 premises may be in different locations or operating trading names but are receiving
 payment through the single supplier record.
