You have asked:

The information provided is incomplete. Please provide details for all councils individually since they are separate legal entities. Please provide the amount of funding given individually itemwise, Purpose of each funding individually.

On 21 June 2023, the Ministry responded and explained to you that any organisations that you had listed which did not feature in our 8 June 2023 tabled response did not receive any funding over the period of interest.

On 22 June 2023, you responded:

I think the message has not got down correctly. What I mean is that the information already provided by you should be provided for Individual councils as you have clubbed all details . Please provide the details in your table individually. Please expedite as its already too late. We can talk if needed.

Any organisations not listed have not had any contract(s) with the Ministry during the 2022/23 financial year.
