On 19 January 2023, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 the following information:

Under the Official Information Act 1982, I wish to request all information regarding the total amount spent on consultants—per consultancy firm—for each of the last six years.

- Please note that the annual reviews do not provide the total amount spent on consultants, per consultancy firm.
- I ask that the information be supplied in the following Excel/Sheets format:

On 17 February 2023, the Ministry emailed you to advise that more time was required to respond to your request for information. The reasons for the extension was that consultations necessary to make a decision on your request were such that a proper response could not reasonably be made within the original time limit and that your request is for a large quantity of official information or necessitates a search through a large quantity of information and meeting the original time limit would unreasonably interfere with the operations of the Ministry.

Following is a table of the total amount the Ministry spent on consultants for the last six financial years which, for the Ministry, start from 1 July and end on 30 June. The information in the table has been extracted from the responses provided in the Annual Review for the last six financial years. This information is reliant on costs being correctly coded as a consultant into our financial management system. As such, we have removed Gateway review activities (\$150,000) by The Treasury which was reported in the 2016/17 Annual Review. We have also removed Vanguard New Zealand Ltd from 2019/20 and 2020/21 as these costs (\$306,236) were fully recovered and no actual costs were incurred by the Ministry, and two contractors miscoded as a consultants.

Please note that for Accenture Ltd, in the year 2021/22, due to data source constraints, figures include both consultancy and contractor spending by the Ministry. In 2021/22 Accenture provided expertise on work related to the implementation of the first release of an Oracle Cloud based Financial Management Information System. Accenture also provided specialist advice on MSD's Te Pae Tawhiti programme. Apart from this, the figures provided are for consultancy fees only, as requested by you.
