Please provide details of the number of Emergency Housing Special Needs Grants, the number of Special Needs Grants and the number of any other Grants paid by the Ministry of Social Development ("MSD") to the owner and/or operator of the following properties for the period 1 October 2022 to 31 March 2023, broken down by quarter.

Please also provide details of the amounts paid by way of each type of Grant in relation to each property for the period 1 October 2022 to 31 March 2023, broken down by quarter. Please advise if the stated amounts paid in each case include or exclude G.S.T.

Please note that not all the suppliers specified in your request received hardship grants in the period 1 October 2022 to 31 March 2023, therefore these suppliers do not appear in this report.

Regarding the second part of your request relating to the benefit information for specific individuals, this information is refused under section 9 (2)(a) of the Act to protect the privacy of natural persons. The need to protect the privacy of these individuals outweighs any public interest in this information.

I note previous correspondence about the volume of these requests, and I acknowledge you continue to be interested in this subject. I would like to invite you to consider whether requesting data on a six-monthly basis (instead of quarterly) would be an option, as this would be of assistance to the Ministry from an administrative perspective. We will continue to consider your requests in either event.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public. The Ministry will do this by publishing this letter and attachments on the Ministry's website. Your personal details will be deleted, and the Ministry will not publish any information that would identify you as the person who requested the information.

- Requested suppliers that did not receive a grant in the period do not appear in this report.
- To protect confidentiality, the Ministry uses processes to make it difficult to identify an individual person or entity from the published data.
- These data tables have had random rounding to base three applied to all cell counts.
- The impact of applying random rounding is that columns and rows may not add exactly to the given column or row totals.
- The published counts will never differ by more than two counts.
- In certain circumstances, low numbers may potentially lead to individuals being identified. Due to privacy concerns, numbers for some categories of clients were suppressed and replaced by an 'S'.
