### **Official Information Act request**

Thank you for your email of 9 January 2024, requesting information about EHSNG payment data relating to Parnell City Lodge.

I have considered your request under the Official Information Act 1982 (the Act). Please find my decision set out below.

#### ***The last EHSNG payment to the lodge***

The last EHSNG payment to Parnell City lodge was made in September 2023.

***The total amount paid for the years 2018 until when it ceased (ie the same information that was provided in the OIA response I attached in my earlier email, but covering the longer period).***

- If a requested supplier has not received a grant in the period they will not appear in this report.


Please note that to protect confidentiality, the Ministry uses processes to make it difficult to identify an individual person or entity from published data. These data tables have had random rounding where, values have been randomly rounded to the nearest multiple of 3. This is applied to all cell counts in the table. The impact of applying random rounding is that columns and rows may not add exactly to the given column or row totals. The published counts will never differ by more than two counts.
