## **Official Information Act request**

Thank you for your email of 27 June 2024, requesting a breakdown of every Auckland-based budgeting service that will have reduced or cut funding from 1 July 2024. I have considered your request under the Official Information Act 1982 (the Act). Please find my decision set out below.

Ministry funding for Building Financial Capability (BFC) core services (financial mentoring and MoneyMates groups services) has reduced by 12.5% for the FY2025 onwards due to the expiry of time limited Covid-19 funding.

We ran a procurement process to refresh the network of Ministry funded BFC core providers from 1 July 2024. This is the first time the Ministry has procured this service since 2016.

Alongside this reduction in funding for BFC core services, the Ministry also changed the funding model for these services. They will now be funded by Full Time Equivalent (FTE) rather a specified number of sessions. This change was communicated with the sector, with 70% of providers surveyed supporting the change in funding model.

Through this change in funding model the Ministry lifted the minimum we pay on every contract. From 1 July, every provider we contract with will be funded for at least 0.5 Full Time Equivalent (FTE), or \$54,000 per provider. This, together with the drop in funding, meant that fewer providers could be offered contracts.

Funding has been allocated through this procurement process to regions and communities with the highest need based on a range of factors which include population, income and hardship data.

Under this new funding model, funding for core BFC services in the Auckland region has increased from approximately \$0.8 million per year to \$6.534 million per year for FY2025 and outyears. This will fund 60.5 FTE positions across 20 providers.

Please refer to Table One in the **Appendix** below for an overview of the changes to the Ministry funded provider network in the Auckland region<sup>1</sup> following the recent procurement process.

Please note that some funding information is withheld under section 9(2)(ba)(ii) of the Act to protect information which is subject to an obligation of confidence where the making available of the information would be likely otherwise to damage the public interest. Where information is withheld, the Ministry is still undergoing contract negotiations with those providers and the funding information has not yet been confirmed.

You are welcome to make a follow up request for this information once these contract negotiations are concluded.

I will be publishing this decision letter, with your personal details deleted, on the Ministry's website in due course.
